FEE STRUCTURE

Adult Recreational Membership.

This membership allows access to boathouse during open hours and LCKC activities and the use of LCKC recreational boats (plastic boats). Open hours change with the season and are subject to change at any time. No boat storage is provided.

LEVEL I Single Membership \$150. per year.

LEVEL II Family Membership \$225. per year. Family is defined as Father, Mother, Brother, Sister or any combination of such, but limited to four family members per membership. Fee for family members over 4 is \$25.00 per year. Anyone under the age of 21 must be accompanied by a parent.

Recreational Boat Storage \$120 per year. Storage of Recreational members boat. Recreational Members are not eligible to use sprint equipment or race with the team. Recreational members receive day camp discounts and access to Moonlight Paddles. (USACK Membership not included, encouraged but not required) **Memberships and boat storage must be paid annually. No monthly or quarterly payments accepted.**

WAIVER, INDEMNIFICATION AND RELEASE OF LIABILITY**

In consideration of being allowed to participate in any way in USA Canoe/Kayak, American Canoe Association, or Lanier Canoe and Kayak Club athletics/sports programs, and related events and activities, the undersigned, for himself/herself, his/her personal representatives, heirs, next of kin:

1. If Minor: Agrees that the parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating he/she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he/she should immediately advise his/her coach or supervisor of such condition(s) and refuse to participate.
2. If Adult: Agree that prior to participating, he/she will inspect the facilities and equipment to be used, and if she/he believes anything is unsafe, he/she will immediately advise his/her coach or supervisor of such conditions(s) and refuse to participate.
3. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses to person or property which might result not only from his/her own actions, inactions or negligence, but also the actions, inactions or negligence of others, the rules off play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
4. Assumes all the foregoing risks and accepts personal responsibility for any and all loss, liability, damages or costs following such injury, permanent disability or death.
5. Releases, waives, discharges and covenants not to sue United States Canoe and Kayak Team, American Canoe Association or Lanier Canoe and Kayak Club, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees or agents of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releases," from any and all claims, liability, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releases or otherwise.
6. Agrees to indemnify and save and hold harmless the releasees from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in any way competing, officiating, observing, or working for, or for any purpose participating in the event.
7. All participants must be able to swim 100 yards and tread water for 10 minutes.
